To: Peconic River Sportsman's Club and its directors, officers, agents, instructors, employees, contractors, representatives, members, volunteers, successors and assigns (hereinafter referred to as the "PRSC"):

Shooting Sports or Events - Definition

In this Agreement, "events" include any and all activities, events, functions, services or facilities provided, organized, sponsored or authorized by the PRSC, including but not limited to: shooting, archery, hunting, competitions, charity events, demonstrations, orientation sessions, seminars and courses, instruction, use of facilities and transportation to and from such activities.

Acknowledgement and Assumption of Risks

- I am aware that PRSC events and all activities related thereto involve inherent risks, dangers and hazards, including the risk of serious personal injury or death.
- I am aware of the risks, dangers and hazards associated with shooting sports and events and I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage or loss resulting from my participation in such activities.
- I further acknowledge the right of PRSC Officers, Employees, or Range Officers to immediately terminate my participation in such activities upon any failure of mine to fully comply with all PRSC Rules, Policies, PRSC Constitution and Operating Guidelines and directions of Range Officers. I hereby state that I am under NO legal injunction or order that prohibits my owning, possessing, handling or using any of the firearms or archery equipment used in the events at PRSC.

Release of Liability, Waiver of Claims and Indemnity Agreement

In consideration of the PRSC permitting me to engage in events and all associated activities and allowing me to use PRSC shooting ranges, equipment and other facilities, and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I hereby agree as follows:

1. I waive any and all claims I have or may in the future have against the PRSC, and I release the PRSC from any and all liability for loss, damage, expense or injury, including death, that I may suffer as a result of my participation in PRSC events.
2. I will be liable for and hold harmless and indemnify the PRSC from all actions, proceedings, claims, damages, costs, including legal costs, and liabilities of every nature or kind arising out of or in any way connected with my participation in shooting sports and/or events.
3. This Release Agreement is governed by and interpreted in accordance with the laws of the State of New York and any action involving the parties to this Agreement will be brought solely within the State of New York and will be within the exclusive jurisdiction of the New York Courts.
4. I am not relying on any representations or statements made by the PRSC regarding the safety of shooting sports, events and activities other than what is set out in this Release Agreement.

I have read and understand this Agreement and I understand that by signing this Agreement I am waiving certain legal rights, which I may have against the PRSC.
